

Dog Training Services Agreement

This Agreement between _____
(hereinafter referred to as "Client") and Underworld Kennels & Dog Training (hereinafter known as "UKDT")
pertains to the following:

For good and valuable consideration, the parties agree as follows:

Training Fees:

\$300.00	Single E-Collar Lesson (recall)
\$400.00	K9 101 Basic Foundations (4 Lessons)
\$795.00	Basic E-Collar Obedience (4 Lessons includes e-collar+Tax)
\$950.00	Canine Good Citizen (8 Lessons+Tax)
\$600.00	Scent Detection (5 Lessons)
\$1400.00	Therapy/ESD Dog Development (#Lessons Varies+Tax)
\$125.00	Public Access Test
\$25.00	Each level of CGC Test
\$125.00	Service Dog Evaluation
\$50.00	Consultation

Client agrees to pay UKDT a deposit of **50%** for the lesson or test package to be scheduled. Balance of \$_____ must be paid in full by 1st lesson. If lesson is canceled 1 month prior to first lesson, **100%** shall be refunded. If the lesson is canceled 2 weeks prior to first lesson **50%** shall be refunded. Cancellation less than 2 weeks prior will result in the entire deposit being deemed non-refundable. All lessons must be completed within 90 days from the date of commencement of contract or they will be forfeited. **Deposit is required immediately to reserve your place on the schedule.**

Services: UKDT agrees to provide private lessons for Client and Dog on a lesson-by-lesson basis, the goal being to teach Client how to train and work with Dog. These lessons can take place at Client's home or UKDT's Facility. UKDT will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Dog's performance or behavior as a result of providing professional animal behavior consultation/training. Client understands that he/she and members of the household must follow UKDT's instructions without modification, work with dog daily as recommended, and consistently reinforce training being given to Dog.

Cancellation Policy: **If Client fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, lesson fees are still due. For a package deal, the lesson will still be counted as one lesson.** If lesson is canceled with 48 hours notice, it will be rescheduled with no penalty.

Liability: If Dog causes property damage, or bites or injures any dog, animal, or person (including but not limited to UKDT and UKDT's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify UKDT and UKDT's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that Underworld Kennels & Dog Training should not be held responsible for any resulting injuries, losses, damages, costs, or expenses.



At UKDT's sole discretion, UKDT's duties hereunder shall terminate if (a) in UKDT's sole judgment Dog is dangerous or vicious to UKDT or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, UKDT's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement is binding upon Client, spouse of Client, and children of Client. This Agreement supersedes all prior discussions, representations, warranties, and agreements of the parties, and expresses the entire agreement between Client and Underworld Kennels & Dog Training regarding the matters described above.

The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations, or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Underworld Kennels & Dog Training has not represented, promised, guaranteed, or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and Underworld Kennels & Dog Training.

The laws of the State of Utah shall govern the validity, construction, and effect of this Agreement. All lawsuits arising out of this agreement, wherever derived, shall be resolved in Box Elder County, State of Utah. Owner agrees to pay court cost, attorney fees and any collection fees if it is necessary to bring action to enforce this agreement.
